By using an online poll provider ([www.pollunit.com](http://www.pollunit.com)) the twelve best rated photographs will be determined and subsequently used for the annual Cluster of Excellence calendar. All contributions submitted by email in accordance with the terms and conditions of the call will be rated on the above-mentioned online poll platform. The polling period will take place from 21<sup>st</sup> October – 31<sup>st</sup> October 2021.

#### **Purpose of data:**

By submitting the photographic contributions by email in accordance with the terms and conditions, the photographers will automatically take part in the Call for Photographic Contributions 2021. The processing of personal data will take place while determining the twelve best rated photographs via a public online poll as well as when publishing the participant’s contribution and name online and when informing the photographer by email on the polling result.

The Cluster of Excellence at the University of Bayreuth intends to use these photographs and the corresponding information (photographer’s place of living, date of birth, image title and short description) in the following manner:

The Cluster of Excellence at University of Bayreuth intends to publish and print the 12 best rated photos as well as corresponding information in the 2022 photographic calendar of the Cluster of Excellence. In addition, the Cluster of Excellence may use the photographs to promote the Call for Photographic Contributions in the future. Additionally, the University of Bayreuth intends to use the submitted contributions as well as the corresponding information to promote the Cluster of Excellence and the University of Bayreuth on its websites and sub-websites (<https://www.uni-bayreuth.de>) as well as its social media channels.

#### **Consent and declaration to the work and its use**

The participants declare their consent that their contributions to the above-mentioned Call may be used by the University of Bayreuth free of charge in a fully comprehensive, spatially and temporally unrestricted, and non-exclusive manner in the way described. The photographs may be processed, edited, combined with other material, reproduced, stored, published and archived for this purpose.

The twelve best rated photographs are eligible for a compensation fee of 350,-- Euro each.

If third-party media will publish the best rated photographs, the participants declare with their registration that these are free of third-party rights or may be used free of charge as part of the promotion of the Call or the Calendar.

The contributors are aware that photos in particular can be copied from the publication media (e.g. internet), used elsewhere and changed without the University of Bayreuth having any influence on this.

The contributors are aware that they can revoke their consent to the recording and storage of this data with effect for the future without any disadvantages arising from this.

The University of Bayreuth is not liable for inaccuracies or mistakes in this English translation. In case of doubt, the German originals are to be used in a court of law.

### III. Data subject rights

#### 1. General

With regard to the processing of your personal data, you as a data subject are entitled to the following rights pursuant to Art. 15 et seq. GDPR:

- You can request **information** about whether we are processing your personal data. If this is the case, you have a right to information about this personal data as well as other information related to the processing (Art. 15 GDPR). Please note that this right to information may be restricted or excluded in certain cases (cf. in particular Art. 10 BayDSG).
- In the event that personal data about you is incomplete or not (or is no longer) accurate, you may request that this data be **corrected** and, if necessary, **completed** (Art. 16 GDPR).



- If the legal requirements are met, you may request the **deletion of** your personal data (Art. 17 GDPR) or the **restriction of the processing of** this data (Art. 18 GDPR). However, the right to erasure pursuant to Art. 17 para 1 and para 2 of the GDPR does not apply if, among other things, the processing of personal data is necessary for the performance of a task which is in the public interest or in the exercise of official authority (Art. 17 para 3 item b GDPR).
- You have the right to complain about the processing of your personal data to a supervisory authority within the meaning of Art. 51 GDPR. The relevant supervisory authority for Bavarian public bodies is the Bavarian State Commissioner for Data Protection, Wagnmüllerstr. 18, 80538 Munich.

## 2. Right of withdrawal

Insofar as processing is based on consent, you have the right to revoke your consent at any time. The revocation only takes effect for the future; this means that the revocation does not affect the lawfulness of the processing carried out on the basis of the consent until the revocation.

## 3. Right of objection

**For reasons arising from your particular situation, you may also object to our processing of personal data relating to you at any time (Art. 21 GDPR).** If the legal requirements are met, we will no longer process your personal data.

## 4. Additional information

Automated decision-making or profiling in the legal sense does not take place. You cannot use the application without providing your personal data.
